Product Description

KWIK-LOK® Pavement Primer is a fast setting pavement primer used to lock down oil spots on concrete and asphalt pavements before sealing.

Recommended Uses

KWIK-LOK primer is specifically designed to seal oil and chemical stains to prevent bleed-through. **KWIK-LOK** primer also aids the pavements ability to bond with pavement sealers. Call UNIQUE's Technical Department for questions related to on-site optimizations.

Benefits / Features

- Ready to use
- Excellent adhesion to pavement surfaces
- Forms a barrier over oil and grease spots
- Locks down tar based sealers before applying environmentally friendly asphalt-based sealers
- Helps prevent oil and grease spots from bleeding up through freshly applied pavement sealer
- Environmentally friendly, water-based formulation

Limitations

KWIK-LOK primer should be used over sound pavement only. If the area is so saturated that the asphalt is soft or crumbly, it should be dug out and patched with UPM® High Performance Cold Mix. **KWIK-LOK** primer should not be applied when the ambient temperature is expected to drop below 50°F.

Preparation

Wash built up oils and dirt from the pavement surface with dish soap or other non-solvent asphalt cleaners. Rinse with water and allow to dry.

Mixing

Shake or stir well before each use.

Placement

The surface should be dry. Primer can be applied directly from the container with a brush or roller, or applied with spray equipment.

Coverage

One gallon of **KWIK-LOK** pavement primer will cover approximately 37.5 square feet (12.5 square yards). Coverage rate will vary due to age, surface condition, and porosity.

Curing

Initial cure time before opening to foot traffic should be 1 hour. Final cure time before opening to vehicle traffic should be 8 hours. Cure time will vary due to ambient conditions. Night applications will take longer than daylight applications.

Storage

Keep from freezing.

Shelf Life

Twelve months in an unopened container.

Color

Green tint/white liquid that dries clear.
